
STUDENT-LED COFFEE SHOP: "THE FARM" USD 239 AMOUNT: \$27,600 FUND: Dane G. Hansen Community Grant Fund

The requested funding was used to help support The Farm with equipment to begin the student-led coffee shop launch. Throughout the 2021-2022 school year, the business class will work to support more staffing at The Farm as these types of skills are in demand across the state and country. KSDE has stressed the importance of soft skills and job skills, along with our Kansas businesses asking for schools to improve on these needed skills.



BENNINGTON GRADE SCHOOL KINDER-GARDEN USD 240 AMOUNT: \$1,332 FUND: Ottawa County Public Health Fund

The funding received allowed Bennington Grade School to purchase a Tower Garden Growing System with accessories to have kindergarten students work together in managing and growing a community garden. Classroom jobs include daily caretakers to check water levels, seedling trays, rockwool pods, and plant growth checks.

Providing Meals with the Ottawa County Summer Café

AMOUNT: \$5,600 FUND: Kansas Health Foundation Fund for Ottawa

Earlier this year, Love in the Name of Christ requested funding for the Ottawa County Summer Café of 2021 to come to life. The purpose of the Summer Café is to provide nutritious grab and go meals each week for those in and around the community.

Through a grant from the Ottawa County Community Foundation, Summer Café was able to purchase an assortment of fresh fruit and vegetables and safely distribute them with the purchase of containers to properly store and distribute the produce. All food items and supplies that were purchased with this grant were purchased locally. Each week the café provided a variety of fresh fruits and vegetables to citizens from surrounding communities.

"Approximately 8500 meals and 900 family meals were delivered to six local communities. Many of these families may not have had access to a local grocery store nor have had the money needed to purchase much produce," said Grantee Colette Henderson.



First Responder's Day Appreciation Project

AMOUNT: \$1,232.43 FUND: The Bennington Community Fund

The Bennington Chapter of the National Honor Society (NHS) was provided funding to recognize the first responders serving their community during the month of October in 2020 to coincide with the National First Responder's Day on October 28.

The lunch they organized for the first responders allowed the students to see them in person and thank them with a meal and gift. The lunch was able to reach about 77 first responders as well as some of their family members. With the help of the funding from the community foundation, NHS was able to show their appreciation for all that the first responders do within their respected community.

STUDENT SPOTLIGHT

\$12,000 IN SCHOLARSHIPS AWARDED



Ottawa County Community Foundation approved scholarships totaling over \$12,000 to three students. Members of our board worked to review applications and select recipients.

NWKansas GIVES

NW Kansas Gives is an initiative through the Dane G. Hansen Foundation to capture the significant transfer of wealth in its 26-county service area. According to a study with the Keep Five in Kansas Campaign, between 2020 and 2064 it is estimated that nearly \$30 billion will transfer from one generation to the next in Northwest Kansas, with \$2.9 billion in Ottawa County.

We are partnering with the Dane G. Hansen Foundation to encourage people like you to consider leaving a portion of your estate to the Ottawa County Community Foundation in a permanent fund to benefit your community forever. If just five percent of the \$2.9 billion, or \$145 million was captured in a permanent fund, it would generate nearly \$6.5 million in annual grants to support causes in Ottawa County.

Donors may also set up an appointment with John Griffin, an estate planning attorney at Stewardship Counseling, free of charge. Once an outline is created, donors work with their existing attorney (or an attorney can be recommended) to complete the documents (paid for by the donor).
